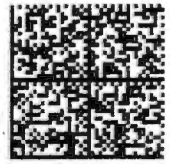

LETTER TO COURT

I USE TO BE IN A CELL JUST ABOVE DEFENDANT RICHARD ALLEN AND AS SOON AS I STARTED VOICING MY OPINION AND ADVOCATING THE ABUSE, MISTREATMENT AND INHUMANE CONDITIONS OF RICHARD ALLEN, MYSELF AND OTHER INMATES BACK IN APRIL 2023 AND RECORDING DATES AND DATES OF INCIDENTS THE CORRUPT WESTVILLE CORR. FAC. WARDEN JOHN GALLIPEAU, CUSTODY SUPERVISOR CHAD CORNETT, WESTVILLE RESTRICTIVE HOUSING UNIT CAPTAIN GARY LEWIS AND MANAGER MRS. TRACY CORNETT RETALIATED ON ME APPROXIMATELY APRIL 29, 2023 AND HAD ME MOVED FROM A-POD AWAY FROM DEFENDANT RICHARD ALLEN. THEN ON MAY 4, 2023 A CORRUPT LIEUTENANT LARRY CRITTENDEN PLACES ME ON STRIP-CELL STATUS AND HAS CORRUPT SERGEANT ROBINSON, OFFICER GARU, AND OFFICER PLEASANT REMOVE "ALL" OF MY PROPERTY FROM MY CELL SO I COULD NOT WRITE OR RECORD DATES AND TIMES OF INCIDENTS AND WENT THROUGH MY PROPERTY TO DESTROY ANY INCRIMINATING DATES AND TIMES THAT I HAD RECORDED. THEN THE CORRUPT STAFF AND OFFICERS LEFT MY PROPERTY UNSECURED OUT IN THE HALLWAY SO GENERAL POPULATION INMATE RESTRICTIVE HOUSING UNIT WORKERS AND INMATE SUICIDE COMPANIONS WERE STEALING MY PROPERTY. I THEN INFORM STAFF/OFFICERS ON MAY 4, 2023 THAT I WAS FEELING SUICIDAL WHERE I THEN WAS TAKEN TO WESTVILLE RESTRICTIVE HOUSING UNIT RECEIVING AREA AND PLACED IN A CELL WITH "NO" TOILET OR RUNNING WATER AND HAD TO RELIEVE MYSELF ON THE FLOOR OF THE CELL.

I WAS PLACED IN "FULL" TRIP-GEAR-RESTRAINTS
WITH HANDCUFFS, BLACK BOX, BELLY CHAIN, AND LEG
SHACKLES ON SECURITY CAMERA AND CORRUPT SERGEANT
BRANDON WILLIAMS, AND OFFICERS REMOVE ME FROM THE
HOLDING CELL TO ESCORT ME BACK TO MY ASSIGNED CELL
IN R.H.U./W.C.U. B6-202 AND SERGEANT BRANDON
WILLIAMS ORDERS ONE OF HIS CORRUPT OFFICERS TO RUN
MY MATTRESS AND BEDDING THRU THE URINE ON THE
FLOOR OF CELL SINCE I WAS LEFT IN A CELL OVER-NIGHT
WITH "NO" RUNNING WATER OR TOILET AND THEN
CORRUPT SERGEANT BRANDON WILLIAMS [NOTE: WHO
HAS A LAWSUIT ON HIM IN THE U.S. NORTHERN DISTRICT
OF INDIANA FOR ASSAULTING A INMATE AND DENYING
THE INMATE MEDICAL TREATMENT FOR HIS INJURIES]
CAN BE SEEN ON SECURITY CAMERAS SLAMMING ME TO
THE FLOOR WHILE IN "FULL" TRIP-GEAR-RESTRAINTS AND
VIOLENTLY TWISTING ON MY FOOT AND ANKLE UNTIL THEY
BREAK AND THEN INTIMIDATING THE NURSE NOT TO TREAT
MY INJURIES OF A BROKEN FOOT AND ANKLE AND
A STAB WOUND TO MY ELBOW ALL THE TO THE BONE THAT
WAS BLEEDING BADLY FROM A INK PEN STICKING OUT OF
SERGEANT BRANDON WILLIAMS STAB-VEST AND I
THEN WAS TAKEN BACK TO MY ASSIGNED CELL B6-202.
THEN AT APPROXIMATELY 10:45 A.M. CORRUPT
SERGEANT BRANDON WILLIAMS RETURNS TO MY CELL
AND WITH "NO" VERBAL COMMAND TO COME TO CELL
DOOR AND "NO" VIDEO CAMERA RECORDING SERGEANT
BRANDON WILLIAMS OPEN THE HAND-CUFF PORT DOOR
IN CELL DOOR AND SPRAYS ME WITH O.C. PEPPER
SPRAY WHILE I WAS LAYING IN BED SUFFERING
FROM MY INJURIES EARLIER THAT MORNING. THEN

THE CORRUPT SERGEANT BRANDON WILLIAMS LEAVES ME IN CELL APPOINTING FOR AIR FOR APPROXIMATELY TEN [10] MINUTES BEFORE REMOVING FROM THE CELL. SERGEANT BRANDON WILLIAMS, FORMER OFFICER AND NOW SERGEANT MOTTS, OFFICER CLEMMONS, AND A UNKNOWN NAMED OFFICER TAKE ME OUT-OF-VIEW OF SECURITY CAMERAS IN THE HALLWAY AND A OFFICER QUINTEN DAVIS TELLS SERGEANT BRANDON WILLIAMS TO HOLD ME UP WHILE OFFICER QUINTEN DAVIS VIOLENTLY PUNCHES ME IN THE RIBS AND STOMACH AND BREAKING MY RIBS AND FORMER OFFICER AND NOW SERGEANT MOTTS KNEED ME IN THE FACE WHILE CORRUPT WESTVILLE CORR. FAC. WARDEN JOHN GALLIPEAU, MENTAL HEALTH DOCTOR MONICA WALA AND MS. BOURNE WATCHED THE BEAT DOWN.

[NOTE! OFFICER QUINTEN DAVIS ALSO HAS A FEDERAL LAW-SUIT ON HIM FOR ASSAULTING A INMATE AND DENYING MEDICAL TREATMENT FOR HIS INJURIES.]

I THEN WAS TAKEN TO WESTVILLE RESTRICTIVE HOUSING UNIT RECEIVING AREA TO BE DECONTAMINATED FROM THE O.C. PEPPER SPRAY AND THEN TAKEN TO THE NURSE'S STATION TO HAVE MY VITAL SIGNS CHECKED AND AGAIN THE NURSE WAS INTIMIDATED NOT TO TREAT MY INJURIES. I THEN WAS TAKEN BACK TO MY ASSIGN CELL B6 202.

[NOTE! THE NURSE AND MENTAL HEALTH MS. BOURNE QUIT THEIR JOB RIGHT AFTER THIS EXCESSIVE USE OF FORCE ASSAULT W/ BODILY INJURY AND MAY BECOME WHISTLE BLOWERS IF INVESTIGATED.]

IN MAY OF 2023 RIGHT AFTER THE EXCESSIVE USE OF FORCE ASSAULT WITH BODILY INJURY ATTORNEY BRADLEY A. ROZZI THE ATTORNEY FOR RICHARD ALLEN REQUESTED AN INTERVIEW WITH ME CONCERNING THE POOR TREATMENT OF RICHARD ALLEN AND INMATES AT WESTVILLE RESTRICTIVE HOUSING UNIT AND INHUMAN, AND HUMAN AND CIVIL RIGHTS VIOLATIONS GOING ON SOMEONE AT EITHER INDIANA DEPARTMENT OF CORRECTIONS CENTRAL OFFICE OR THE WESTVILLE CORR. FAC WARDEN JOHN GALLIPEACI DENIED THAT INTERVIEW BECAUSE THEY DID NOT WANT ATTORNEY BRADLEY A. ROZZI TO SEE AND RECORD MY INJURIES THAT THEY WERE TRYING TO COVER-UP.

I REMAINED IN A CELL FOR OVER A MONTH SUFFERING FROM MY INJURIES BEFORE I RECEIVED MEDICAL TREATMENT AFTER BEING TAKEN OFF OF STRIP-CELL AND RECEIVING MY PROPERTY BACK AND CONTACTING THE STATE OF INDIANA GOVERNOR'S OFFICE OF OMBUDSMAN BUREAU WHO CONTACTED THE I.D.P.C. OFFICE OF INVESTIGATIONS & INTELLIGENCE WHO THEN GOT ME MEDICAL TREATMENT FOR ONLY MY BROKEN FOOT AND ANKLE WHERE X RAYS CONFIRMED WERE BROKEN.

RICHARD ALLEN ATTORNEY BRADLEY A. ROZZI WAS NOT GIVEN ACCESS TO INTERVIEW ME UNTIL AUGUST 4, 2023 APPROXIMATELY THREE [3mos.] MONTHS AFTER THE EXCESSIVE USE OF FORCE W/ BODILY INJURY.

I RECEIVED POOR MEDICAL TREATMENT FOR MY INJURIES, WESTVILLE CORR. FAC. DOCTOR LIAW AND A FRANCISCAN ORTHOPEDIC DOCTOR ORDERED ME TO BE PLACED IN A "MEDICAL BOOT" BUT CORRUPT WARDEN JOHN GALLIPEACI, CUSTODY SUPERVISOR MAJOR CHAD CORNETT, AND CAPTAIN GARY LEWIS VIOLATED THE UNITED STATES AND UNITED NATIONS RULES FOR THE TREATMENT OF PRISONERS CALLED

[NOTE: WHILE BEING INTERVIEWED BY ATTORNEY BRADLEY A. ROZZI ON AUGUST 4, 2023 A CORRUPT SERGEANT DALIA WENT TO MY CELL B6-22 AND TOOK ALL THE INCRIMINATING DATES AND TIMES OF INCIDENTS THAT I RECORDED.]

called [THE NELSON MANDELA RULES] that state the following: Clinical decisions may only be taken by the responsible health-care professionals and may not be over-ruled [OR] ignored by non-medical prison staff.

All prisons shall ensure prompt access to medical attention in urgent cases, prisoners who require specialized treatment or surgery shall be transferred to specialized institutions or hospitals.

The corrupt Indiana Department of Investigations & Intelligence has seemed to cover-up the excessive use of force assault with Bodily Injury and has closed the case. The corrupt Indiana Dept. of Corr. Office of Investigations & Intelligence is quick to collect evidence and charge inmates who assault staff and officers but seem to cover-up when corrupt staff and officers assault inmates. The Indiana Department of Correction should not be allowed to "Police" itself and allow corrupt investigators of the Office of Investigation & Intelligence who some use to be either I.D.O.C. staff or correctional officers and are friends with the corrupt I.D.O.C. staff and officers that the investigators are supposed to be investigating.

There needs to be a "disbanding" of the corrupt I.D.O.C. Office of Investigations & Intelligence and state and federal investigations into the corruption going on and the inhumane conditions, human and civil rights violations due to constant staff and officer shortages going on in "All" I.D.O.C. facilities that is creating unsafe and dangerous prison conditions.

ON November 8, 2023 A INMATE AT WESTVILLE CORR. FAC. WAS MURDERED. APPROXIMATELY IN JUNE 2023 A INMATE DIED OF STARVATION IN WESTVILLE RESTRICTIVE HOUSING UNIT. INMATES HAVE DIED OF SUICIDE IN I.D.O.C. FACILITIES DUE TO THE CORRUPTION.

FOR AN EXAMPLE: I, ROBERT P. BASTON #209216 AT PENDLETON CORR. FAC. RESTRICTIVE HOUSING UNIT SWALLOWED FIFTY [50] 325 mg. TYLENOL PAIN RELIEVERS AND WAS TAKEN TO HOSPITAL VIA AMBULANCE AND SPENT FOUR [4dys] IN ST. VINCENT ASCENSION HOSPITAL INTENSIVE CARE UNIT. I THEN WAS TRANSFERRED TO WESTVILLE RESTRICTIVE HOUSING UNIT WHERE THE I.D.O.C. MEDICAL PROVIDER "CENTURION" DOCTOR LIAW WAS NEGLIGENT WHEN PRESCRIBING ME 500mg. TYLENOL WITHOUT CHECKING MY MEDICAL AND MENTAL HEALTH RECORDS WHERE I AGAIN ON MARCH 21, 2023 TOOK FIFTY [50] 500mg. TYLENOL AND HAD TO BE TAKEN TO HOSPITAL VIA AMBULANCE AND WAS IN FRANCISCAN HOSPITAL INTENSIVE CARE UNIT FOR THREE [3dys.] DAYS, LESS THAN A YEAR ON APRIL 9, 2022 AT PENDLETON CORR. FAC.

AS OF THIS DATE AND TIME THE INDIANA DEPT. OF CORRECTIONS AND THEIR MEDICAL AND MENTAL HEALTH PROVIDER STILL HAS NOT OFFERED ANY MENTAL HEALTH TREATMENT WHEN IT IS DOCUMENTED IN MY MEDICAL AND MENTAL HEALTH RECORDS OF MULTIPLE SUICIDE ATTEMPTS AND SERIOUS HUNGER STRIKES.

THE INDIANA DEPT. OF CORR AND THEIR MEDICAL AND MENTAL HEALTH HELP TO ME HAS ONLY BEEN ONCE A WEEK COME BY CELL WELLNESS CHECK AND A ONCE A MONTH OUT-OF-CELL CONSULTATION IF THE I.D.O.C. AND THEIR MEDICAL AND MENTAL HEALTH IS NOT SHORT STAFFED OR SHORT ON OFFICERS TO ESCORT A INMATE TO A MEETING ROOM/CUBICLE WITH A MENTAL HEALTH PROFESSIONAL. THAT IS NOT MENTAL TREATMENT. IF I REMAIN IN I.D.O.C. RESTRICTIVE HOUSING I WILL COMMIT SUICIDE.

THEN THERE IS A VERY SERIOUS ISSUE OF DEFENDANT RICHARD ALLEN, OTHER INMATES, AND MYSELF BEING EXPOSED TO DANGEROUS TOXIC SECOND-HAND SMOKE FROM INMATES IN WESTVILLE RESTRICTIVE HOUSING UNIT SMOKING K2-SYNTHETIC MARIJUANA THAT IS AFFECTING HEALTH AND MENTAL HEALTH OF INMATES AND STAFF AND OFFICERS. I HAVE SUBMITTED MANY GRIEVANCES CONCERNING THE DANGEROUS TOXIC SECOND-HAND SMOKE AND CORRUPT OFFICERS EITHER TRAFFICING WITH INMATES [OR] ASSISTING IN INMATES TRAFFICING OF CONTRABAND AND WESTVILLE CORR. FAC. CUSTODY STAFF AND THE I.D.O.C. OFFICE OF INVESTIGATIONS & INTELLIGENCE HAS MISHANDLED THOSE GRIEVANCES AND COMPLAINTS. I HAVE CONTACTED MRS. EMILY BAZELON, A NEW YORK TIMES INVESTIGATIVE REPORTER AND HER TEAM AT UNIVERSITY OF YALE LAW SCHOOL WHO HAS CONTACTED A MR. CHAD BLACKWELDER AT THE A.C.L.U. OF INDIANA AND I HAVE RECEIVED INVESTIGATIVE

WESTVILLE RESTRICTIVE HOUSING UNIT CUSTODY STAFF
SAY THAT THEY CARE ABOUT INMATES "QUALITY OF LIFE", BUT
I HAVE NOT HAD A SHOWER SINCE OCTOBER 2, 2023 AND
THERE'S OTHER INMATES THAT HAVE NOT SHOWERED LONGER
THAN THAT BECAUSE INMATES DO NOT WANT TO SHOWER
WHEN OFFICERS ARE LEAVING INMATES LOCKED-IN A TINY
TRIANGLE SHOWER FOR HOURS W/ NO PLACE TO SIT DOWN
AND HAVING TO STAND BECAUSE OF SHORT STAFFED OR OFFICERS
SLEEPING IN THE CONTROL BOOTHS [OR] IN ONE OF THE OFFICES.
INMATES IN WESTVILLE RESTRICTIVE HOUSING ARE BEING
SERVED INDIANA DEPT. OF CORRECTIONS / ARAMARK FOOD
SERVICE MEALS THAT ARE OVER-COOKED AND BURNT AND
OFTEN ITEMS MISSING FROM TRAYS THAT ARE ON THE MENU.
THE BREAKFAST CONSIST OF CORNFLAKE CEREAL, CAKE,
PEANUT BUTTER JELLY MIX THAT UPSETS YOUR STOMACH AND
GIVES YOU DIARRHEA, TWO SLICES OF BREAD AND A KOOLAID
PACKET THAT SUPPOSE TO BE FRUIT JUICE [OR] A PIECE OF
FRUIT. TRY EATING THAT EVERY DAY SEVEN DAY A WEEK.
AT OTHER I.D.O.C. FACILITIES BREAKFAST CONSIST OF A
HOT BREAKFAST SUCH AS EGGS, OATMEAL, AND OTHER ITEMS.

THE CORRUPT WESTVILLE CORR. FAC WARDEN JOHN GALLIPEAU DOES NOT ALLOW THE CHRISTIAN AMISH CHURCH GROUP CALLED CHRISTMAS BEHIND BARS TO PASS-OUT CHRISTMAS SACKS TO INMATES BECAUSE WARDEN JOHN GALLIPEAU IS THE LEADER HERE OF A "PAGAN WHITE NATIONALIST GROUP CALLED "ODIN". THE CORRUPT STAFF AND OFFICERS HERE AT WESTVILLE CORR. FAC. AND AT OTHER INDIANA DEPT. OF CORRECTIONAL FACILITIES WEAR "ODIN" AND PUNISHER PATCHES ON THEIR UNIFORMS AND STAB-VEST. THE CORRUPT STAFF AND OFFICERS THAT WEAR THE "PUNISHER" PATCHES IS A GROUP OF GOOD-"O"-BOYS THAT ASSAULT, TORTURE, ABUSE, AND MISTREAT INMATES. I SUBMITTED A I.D.O.C. GRIEVANCE TO THE I.D.O.C. OFFICE OF INVESTIGATIONS AND INTELLIGENCE CONCERNING THE "ODIN" AND "PUNISHER" PATCHES BUT THE GRIEVANCE NEVER GOT PROCESSED DUE TO THE CORRUPTION.

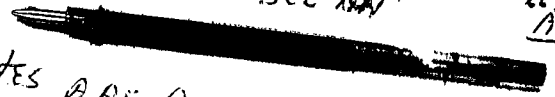

ESTES] THAT THE GRIEVANCES WERE FORWARDED TO HER FROM THE GRIEVANCE SPECIALIST MS. SHANNON SMITH AND THAT THE GRIEVANCES WILL BE ANSWERED AFTER THE INVESTIGATION IS COMPLETED. I WAS INFORMED ON NOVEMBER 2, 2023 THAT THE INVESTIGATION WAS CLOSED BY INVESTIGATOR MS. ESTES AND THE GRIEVANCES STILL HAVE NOT BEEN ANSWERED AND A REQUEST FOR ACCESS TO PUBLIC RECORDS WAS DENIED WHEN I REQUESTED THE SECURITY CAMERA EVIDENCE OF THE EXCESSIVE USE OF FORCE ASSAULT, INCIDENT REPORTS, GRIEVANCES, AND OTHER DOCUMENTS.
